Dear Members of the Iowa House and Senate:

We write to you today as Iowa State University alumni and on behalf of over 600 other concerned citizens, including Iowa farmers and many other Iowa State alumni, regarding the proposed budget cuts in the education appropriations bill. The proposed bill would eliminate the Leopold Center for Sustainable Agriculture. In this letter, we have included the many the hundreds of comments we received overnight to demonstrate the broad public support for the Leopold Center's role in fulfilling its legislative mandate to:

(1) identify the negative environmental and socioeconomic impacts of existing agricultural practices, (2) research and assist the development of alternative, more sustainable agricultural practices, and (3) inform the agricultural community and general public of the Center's findings.

It is imperative that the Center be funded in full and that the state's public funds dedicated to research on water quality continue to be managed through the Leopold Center's transparent grant making process, as was initially mandated by our state legislature at the Center's founding.

As Iowa State University graduate students, we personally benefited from the Leopold Center for Sustainable Agriculture's research grant funding. The broader community of nonprofits, farmers and land managers also benefit from the applied research and outreach that the Leopold Center has supported. Further, their leadership in building a long-term vision of agriculture in Iowa state that is economically and environmentally viable has brought benefit to **all** Iowans and much of the U.S. Midwest. Simply put, the committee's funding decisions demonstrate a short-sightedness for the greater good of the state, and simply kick the can down the road for future generations to deal with the economic, environmental, and human health costs and challenges of water pollution and climate change. These issues will not go away by eliminating the Leopold Center.

Further, we are extremely disappointed with the rushed and secretive nature of these budget decisions. This process has not been transparent and has limited the ability of Iowans and ISU alumni to thoroughly participate and express our perspectives. We call for a public hearing to provide Iowans the opportunity to share testimony before a vote on the budget.

We started a [petition](#) earlier this week to aggregate public support which now has over 600 signatories. Please see the below comments from concerned citizens, which demonstrate the wide support for the Leopold Center's work and mission. We will continue to share the updated petition and comments.

<p>My family has farmed in Iowa since the 1800's. We consider ourselves scientific farmers and we use Leopold Center funded research to make our farms both more environmentally and financially sustainable.</p>
<p>In my community of Dubuque, nearly 1/3 of residents are obese. In some schools, nearly 1/2 of students are considered overweight. The Leopold Center for Sustainable Agriculture has supported research on Food Hubs which has been instrumental in making healthy fresh food grown by local family farm businesses available and accessible to children who most need it.</p>
<p>The LCSA has consistently supported soil and water quality research with an Iowa-focus, enabling practical research that wouldn't be funded by other entities, especially federal agencies. LCSA research underpins and enabled the Iowa Nutrient Reduction Assessment and Strategy, and is the reason we have a path forward to clean water and sustainable agricultural production in the state. There is much research and action left to do, and LCSA knows what it is and how to get it done. LCSA is more critical now than ever!</p>
<p>I'm a Co Soil Commissioner and research Helps us. Farmers need help saving soil. Our county has the most terraces of any county in Ia</p>
<p>I was a student and graduate assistant at Iowa State University between 2009-2012. I worked on a multidisciplinary project "STRIPS at Neal Smith" that was supported by the Leopold Center. Our research found that planting small strips of prairie into rowcrop fields has disproportionately large benefits, such as 90% decreases in soil loss, 85% decreases in nitrogen loss from surface runoff, and huge increases in biodiversity on the landscape (<a href="https://www.nrem.iastate.edu/research/STRIPS/">https://www.nrem.iastate.edu/research/STRIPS/</a>). This practice is now being incorporated on farmer fields across Iowa. This is just one example of the MANY impactful projects that the Leopold Center has supported.</p>
<p>The Leopold Center is important to me in so many ways. The staff and board are a source of inspiration, provide critical feedback on my research, and help promote my research. The Leopold Center has provided critical funding to my lab which has been used to leverage other state, federal, and private dollars. Thus funding has supported research that has gained attention across the Iowa countryside, regionally, and nationally. It has supported the training of dozens of students. It has generally made Iowa a better place to live, work, and play in.</p>
<p>The Leopold Center makes a positive difference to the lives of Iowans as well as to the state's agricultural landscapes. Not only does the state and its residents benefit from the work of the Leopold Center, but states and institutions across the United States look to the Leopold Center for its leadership in sustainable agriculture. When I tell people I was at Iowa State generally the first thing they say to me is, "Oh that's where the Leopold Center is. They do such good work!" Why would we defund something that makes such a positive contribution to our own wellbeing and promotes the state and its opportunities beyond the borders of the state?</p>
<p>"The Leopold Center for Sustainable Agriculture at Iowa State University was created to identify and develop new ways to farm profitably while conserving natural resources as well as reducing negative environmental and social impacts. " The Leopold Center for Sustainable Agriculture is an Iowa treasure!</p>
<p>A bastion of important think tank research to make our state a competitive viable, competitive state as it sustains viability for future generations</p>
<p>A lot of good work has come out of the center re: land management practices in the state. If the legislature is serious about addressing Iowa's nutrient and land management challenges then cutting support for the Center makes no sense whatsoever.</p>

Achieving sustainable agriculture requires study, both quantitative and qualitative for the future of farming as well as the safety of all of Iowa's residents.
Agriculture and natural resources are an important part of Iowa and its economy.

Fully fund the Leopold Center to keep Iowa from being the next Flint!

As a local foods advocate, educator, and Iowa Food Hub director, I can not imagine living in Iowa without the continuing foundational support from the Leopold Center. It has been one of the leading forces for local food system development work; and critical to advancing sustainable and regenerative agriculture practices. Please continue to support this worthy organization to make Iowa great again!

As a manager of a nonprofit, I can vouch for the Leopold Center's value on a professional level. The organization has funded a number of research projects for our organization that have allowed us to further research in local foods arenas.

The research that the Leopold Center conducts and supports is not only beneficial for those who are direct beneficiaries. Each county in Iowa has been granted support through Leopold Center funds, and the research conducted is recognized as a benchmark in innovative agricultural development nationwide. In addition to providing funding for grantees and other partners, the Leopold Center is able to leverage a great amount of funding with each project. Without the Leopold Center, Iowa would suffer a great loss, and may no longer be a leader in innovation in agriculture.

As a resident of Iowa, the work done at the Leopold center on water quality and nutrient reduction directly affects my quality of life and health. Please don't defund such an important organization.

As a small scale farmer, I rely on the important work done for soil and water quality by the Leopold Center for Iowa and Iowans. I am extremely disappointed by this year's legislative session and the poor choices made by greedy and short sighted politicians.

As a wildlife biologist, the connections between healthy agricultural practices and healthy wildlife populations is vital. Healthy wildlife populations are indicators of healthy habitats. Healthy habitats are indicators of healthy ecosystems. Healthy ecosystems means humans have a better chance to be healthy, too, as we are an integral part of these ecosystems. We continue to ignore that fact. The Leopold Center conducts critical research and provides critical information for the greater good. It's that simple.

As a young adult, the move toward local food is very important for my future. As we encounter more environmental issues that affect food and water availability/cleanliness, etc, I wanted to be assured that I can get the food and water I deserve in the future. The focus on corporate farming in Iowa (and other midwest states) is disheartening, because it goes against my desire for people to have access to cleanly produced food. While I understand many people need to be fed and large farms are a way to do this, I strongly believe that places like the Leopold Center use their outreach programs in important ways, which teach people self-sustainability practices that better their food and the food of their community.

As an agricultural state it is important that we lead the way for the United States and the world in sustainable agriculture.

As an agricultural state we need to continue research to make sure that are soil and water resources can support future generations of

Iowa both rural and urban.
As an Iowa native and landowner, I have tremendous respect for the research conducted by the Leopold Center. Our family has owned our farm in Iowa County since 1856, and we have directly benefitted from the prairie STRIPs project that is generously supported by them. We are proud to be early adopters of prairie strips on our land, greatly reducing the runoff of nutrients and soil.
As farmers, my husband and I value the research at the Leopold Center. We are always looking for ways to improve our farm operation.
As I sit here, preparing for a faculty committee meeting regarding sustainability at Naropa University, which my Ph.D in Sustainable Agriculture from Iowa State landed me, I am appalled to learn that the Iowa legislature is poised to defund the Leopold Center. When I talk about the state of Iowa, with regard to sustainability, to my colleagues around the country, the Leopold center inevitably gets brought up, sometimes by the out-of-staters! The Leopold center stands as a testament to the power of compromise and bi-partisanship. It was formed through a bi-partisan bill. Its board is comprised of leaders in *both* industrial and ecological agricultures. The only explanation I can come up with as to why the legislature is attempting to defund the center is an ideological one. In its 30 years of existence, the Leopold Center has always been a beacon of the future, and one that does the empirical research to help farmers to live into that future. Today, sadly, it appears that the Iowa legislature is acting out of the crippling partisan ideology that is running rampant all over this country right now. For the sake of doing what's right, as well as for the sake of future generations of Iowans-- both farmers and eaters, we must stop the bill that is threatening the future of the Leopold Center.
As our social and environmental climates change, it is necessary to develop alternative forms of agriculture that are sustainable over the long term. The Leopold Center is at the forefront of such crucial research and development. It is an invaluable resource nationally and a point of pride for Iowa.
As someone with an invested interest in food security and agriculture in Iowa, the Leopold Center has been an irreplaceable resource for information concerning everything from available C.S.A. subscriptions to food and vegetable production budgets. I don't want to get cancer or have any of my loved ones get cancer because of pollution caused by unsafe agricultural practices that pollute the air my family breathes and the water we drink.
I first learned about the Leopold Center while living in Florida. I was able to learn about the issues related to Iowa agriculture and to our food system through its website. When I was able to move back to Iowa, what I had learned from the Leopold Center helped me become a better farmer, a more aware consumer, and a person who was very happy to live in such an exciting state. It gave me hope. I believe the Center must be funded to continue giving hope to Iowans for a future that values its rural communities, its farmers and growers, and its environment.
I have worked all of my adult life to support environmental issues and to protect and restore our land. The information from the Leopold Center is key to informing us how to live on and treat our land, water and air.
I have worked closely with people in the Leopold Center and have cited research findings conducted at the Leopold Center in my own research. I also see our teaching and research institute In Florida look for information from the Leopold Center publications. Their research studies are fundamental to the sustainability of agriculture and natural resources and to the wellbeing of all Iowans and US residents.
I know couples graduate students are using this fund for their research.
I live in rural Iowa and sustainable agriculture is the future.
I most recently lived in Iowa where I attended Leopold Center sponsored lectures regularly. It was very clear to me how valuable the Center is not only for Iowa but for the national conversation around sustainable agriculture. I currently live in Nebraska, where I am a multi-generation landowner where we have managed a ranch in the Sandhills with rotational grazing for over forty years. I think it would be a huge disservice for agriculture not to have an independent organization such as LCSA who distribute grant funds to researchers developing new techniques for ranches and farms like my family's. I myself am investigating opportunities to build my own business (beekeeping and craft beer/small grains/hops) and research such as that supported by LCSA can offer support to small business owners as they get enterprises off the ground. Investing in agriculture is always a wise decision, so let's keep it accountable, independent and focused on sustainability. My family would not have our ranch in Nebraska if we did not practice holistic management that has buffered us against drought. I truly think places like the Leopold Center help make alternatives a reality, and help keep families on their land.
I rely on the Center's work for information on soil health and other farming topics. Their use of funding is wise, and their work is appreciated by all who know of it--even out here in rural Minnesota.
I retired after 30 yrs. working for the IDNR and it was evident across the state that the LC had accomplished more than most people would understand.

In a state so often defined by its agricultural past and present, the Leopold offers a shining example of the options and alternatives available to farmers and consumers alike.
In order to achieve a 45% reduction in nutrients in our waterways the Iowa Nutrient Reduction Strategy recommended adopting a suite of conservation practices. While we are about halfway in our no-till goal, we have achieved less than 1% of our goals in cover crops, wetlands and bioreactors. We have not 'achieved' sustainable agriculture in Iowa and we haven't 'fixed' our water quality.
Independent research results, untainted by corporate greed, are essential to solving the water quality problems of this state.
Innovative research and outreach.
Iowa agriculture is far from sustainable. We have a lot to do to farm in a way that allows for clean air and water. We also have a lot of work to do to maintain our own state-level food security through increased infrastructure that builds a local food economy throughout the state. Iowan's should eat local!
Iowa farmers interested in protecting Iowa waters and farming their land so it will be as productive for their children and grandchildren as it is now need the expertise the Leopoldo Center has to offer.

Iowa is an agriculture state and sustainable ag is the future! Sustainable ag is also an economic development opportunity that increases our economy and tax base.
Iowa is first and foremost, an agricultural state. Iowans have a deep connection to the land, the air, and the water that not only provides economic support for many, but sustains life in the heartland. Last, as a small scale farm partner, our farm has benefited from the Leopold Center's support of organizations like Practical Farmers of Iowa. The Leopold's work is not done. We need more of the center's expertise in Iowa and nationwide, helping us mitigate the tremendous challenges in agriculture.</p>
<p>The Leopold Center has been critical in support of local foods. This is (among many positives) a significant economic development opportunity. Small food farmers are very important to our area and state. Dollars going to Leopold return many fold in outside money and new opportunities.</p>

The Leopold Center has been a leader in all of these areas.</p>

The Leopold Center has sponsored the work of Iowans concerned about their water and soil resources through more than 600 research projects---on topics spanning water quality, manure management, livestock grazing, cover crops, alternative conservation practices, biomass production, soil health and the seminal work in local food systems development in Iowa. The results of these projects provided information that directly benefited Iowa farmers.

If you look at just six of the major projects the Center funded, for every dollar the Leopold Center spent on these projects, an additional \$4.60 was leveraged to complement or expand the work. (<http://www.leopold.iastate.edu/change>) And all this money went to Iowans to help conserve Iowa's precious natural resources.

Sustainable agriculture is an imperative in our state. We do not want to end up like states that mined their natural resources and now there is nothing left.

I am a rural resident and I deeply resent the poisoning of the Des Moines River by eroded soil laden with herbicides, insecticides, fungicides and expensive manufactured fertilizers that increase eutrophication of rivers and streams. Claiming that the work of the Leopold Center is finished - is either a deliberate lie, or the thoughts of the willingly benighted. The work of the Leopold Center is just beginning. The Iowa Legislators who presume to take away funding for this important work do this because they know research generated proves that agriculture can be done differently and more sustainably.</p>

I can only surmise that this cabal of legislators are more loyal to the dark money infusing their campaign accounts than they are to Iowa Citizens and future generations of Iowa's children.
The world needs healthy soil and clean water for a sustainable future!
Their research has supported the creation of hundreds of new jobs across Iowa
Their research improves our environment and family farms
Their work is critically important to Iowa's water quality, local foods networks, and so much more of the things Iowans are dependent on
Their work is much too important to be limited, let alone defunded entirely. Their research is valuable and truly helps American agriculture. We are at the crux of a better way of producing food in Iowa and the Leopold center provides the opportunity and leadership for us. We desperately need better cleaner agriculture in Iowa.
We are blessed with Iowa's rich natural resources and Leopold Center has contributed greatly to protect Iowa's soil and water. Don't take the bless away.
We are not living or farming sustainably. Our earth is in trouble and we need places like the Leopold Center to do the research that we so desperately need. Defunding this now would be a colossal mistake and end up costing us a lot more in the future.
We can't ignore environmental issues that will inevitably affect the quality of life that Iowans now enjoy. I support local food movements in North Iowa that have benefited from a Leopold Center grant and ISU consultation. This program offers the connection between the university and the local citizenry that helps Iowa grow economically and

environmentally. Please continue funding this important program!
We need to keep the brightest minds working on research in Iowa
We need to keep working on all phases of sustainable agriculture for the health of our people and the health of our land.
We want Iowa to be known as the " healthiest state". This goes hand in hand with the work of the Leopold Center. It is unacceptable to take away these funds.
We've all benefitted from the Leopold Center's programs and research. Don't let politics get in the way if science. How about cutting tax breaks instead of cutting programs.
What educated, thoughtful person who cares about the future would NOT want to fund research that leads to a better life on this planet for everyone??? This is a total no-brainer!
Where do I begin? I want to leave a healthy and sustainable environment for future generations.
Why are they trying to impede sustainable farming? Other than supporting industries were the long term viability of the land and its people take the back burner and get burnt.
Why would you want to get rid of the Leopold Center when they are providing research needed to keep our water and soil resources at a high quality.
With only 478,000 Iowa farmland acres representing less than 2% of Iowa's 30 Million Agricultural Farm land using cover crops as means to regenerate soils, build organic matter, prevent further soil erosion and as a means to reduce nitrate and phosphorous pollution of our vital drinking sources, coupled with reducing the dead zone down stream, how can we in good conscience not fund the Leopold Center? Where else does Iowa farmers and ranchers have a research based "Home Grown" place to turn to that provides unbiased expert advise that allows for methods and applications that will restore Iowa's fertile valleys, soils and water using vital proven regenerative methods? The idea that 98% of Iowa Farm lands are still in the year 2017 using production methods that assure sterility of biological soil activity, erosion of top soil and overall degradation of our most productive farmlands is the greatest crime against humanity imaginable.
With the exception of four years in the U..S. Navy, my life has in some way been connected to agriculture. This includes graduating from Iowa State with a B.S. in Agriculture, working on farms, working in Ag Extension, and working and retiring from FmHA, and in addition living on a small farm for 46 years, where we installed waterways, tile, and terraces. Nothing is more important to Iowa than the conservation of our soil and water resources. The Leopold Center has been a leader in these efforts. At age 86 what happens will have little effect on me personally. However, I am very concerned about the conservation of our soils and natural resources for future generations. I urge you not to cut funding for the Leopold Center.
Work from the Leopold Center and it's funding has been fundamental in understanding issues surrounding and in developing improved practices for improved water quality; diverse cropping systems, including organic agriculture; sustianable grazing systems and modern agroforestry. Hard to imagine Iowa in 2017 without this great work to inform our important agricultural decision so today.
